



## SPORT CLUBS PARTICIPATION ACTIVITY RELEASE FORM

This release waiver and hold harmless agreement is required for participation in all sport clubs, curricular and non-curricular, sponsored by Carroll Community College. All participants must sign and date the form in order to participate regardless of whether the participant is a student at Carroll Community College. Completed forms must be returned to the College representative supervising the activity prior to participation and must be kept in the Office of Student Life for three years.

I have read and understand the Standards of The Code of Integrity- Student Conduct, Section II, as written in the *Carroll Community College Catalog, College Regulations/Polices, Section Six: Code of Integrity* and agree to abide by them. I understand failure to abide by the rules and regulations may result in unnecessary harm to me (or my child) or others and result in my termination (or my child's) from further participation in sport club activities.

I acknowledge that my participation (or my child's) in the sports club named above is completely voluntary, and I understand that this type of activity may entail various unknown risks, including but not limited to the possibility of unforeseen adverse physical injury. I understand that participating in a CCC Sport Club can be rough and dangerous and that all types of bodily injury and disability are a risk of participating in CCC Sports Club, and I voluntarily assume the risks associated with the activity. Further, I acknowledge that I am fully responsible for my physical condition and conditioning. The College does not provide health and accident insurance for sports activities, and I understand that any medical expenses, property loss, or other personal expenditures that result from this activity are to be borne by the student/participant or by their parent or guardian (if student/participant is a minor). I also hereby consent and give authorization to activity leaders to secure any emergency medical treatment in event I am unable to, and I agree to be responsible for the costs thereof.

I further acknowledge that if I drive my own vehicle, or if I am a passenger in another's private vehicle in connection with this activity, that Carroll Community College's auto insurance does not cover such a private vehicle. I also understand that the College cannot be responsible for assuring the safety and reliability of such private transportation or driver for any non-sponsored activities and travel that I choose to participate in before, during, or after the College sponsored function, and I therefore accept the risks and responsibilities associated with such private vehicle travel.

I understand that by executing this release and hold harmless agreement that I waive on my behalf (and my child's) any future right to seek redress against the College in any forum for incidents or actions, which may occur as a result of my (or my child's) participation in this activity.

Therefore, in exchange for being able to participate in sports activities (or my child), I for myself (or my child), family, estate, successors, and assigns, do hereby fully and unconditionally, forever release and hold harmless the Carroll County Commissioners, Carroll Community College, including its Board of Trustees, employees, agents, officers, volunteers, successors and assigns, from claims, liabilities, damages, demands, costs, expenses or judgments including attorney's fees and court costs (hereinafter collectively referred to as "claims") due to injury or loss in any way connected with my participation (or my child's) in the activity, except to the extent such injury or loss results from the sole negligence of the College or its officers, employees, volunteers, or agents.

**I execute this Waiver, Release and Hold Harmless Agreement voluntarily and certify that I have read, fully understand, and agree to the terms of this Agreement in consideration for the College permitting me (or my child) to voluntarily participate in sports club activities. I acknowledge that I have been given the opportunity to consult with an attorney prior to the execution of this Agreement.**
